- Income from Trusts and Partnerships (Distribution Statements)
- Rental Property Income (refer to the Rental Property Checklist on our Website)
- Any Other Income

## Deductions

- Work related Travel and Motor Vehicle Expenses (Business Kilometres, Logbook)
- Work related Protective Clothing and Uniform Expenses
- Work related Self Education Expenses (e.g. Course fees, Seminars, Conferences, Books, Stationery and Travel to the Course)
- Subscriptions (Union Membership, Professional Body Membership, Licensing)
- Donations of \$2 and over (School Building Fund Donations, Library Trust)
- Tax Agent's Fees
